This notification is implied for the above mentioned 7 (seven) districts.

MULTI VILLAGE WATER SUPPLY & SANITATION COMMITTEE (MVWSC) COMPOSITION:-

The Committee shall include the following:

Sl.No.	Constituents	Formation
1.	Chairperson	Zilla Parisad President
2.	Vice-Chairperson	Zilla Parisad,CEO
3.	Member Secretary	Executive Engineer(PHE)of the Project executive Division
4.	Member	President from project area GPs,Anchalic Panchayat Member& Zilla Parisad
5.	Selected Member(at least two)	Representatives of NGO/SHG/Youth Group/Citizen Group (from project area)

Note:

1. Minimum number of Member shall be 8(eight).
2. 10% of the total members &selected members (as mentioned in Sl.4 &5 above) shall belong to SC/ST community.
3. About One fourth of the total members & selected members (as mentioned in sl.4&5 above) shall be woman.
4. The members shall have attend the age of 18(eighteen)years or above.
5. The term of committee shall be co-terminus with the term of Zilla Parishad reconstitutes it.
6. The Treasure of the Committee shall be selected from among the committee Members by the members.
7. The Vice-Chairman shall chair the chair meeting of the commit in absence of the Chairman.

Function of the MVWSC

General

- 1.1 The members should have a strong concern for equity and pro poor bias.
- 1.2 The members should be gender sensitive.
- 1.3 The members should be willing to volunteer for the work entrusted with them.
- 1.4 The members shall provide information related to the project to other members to enable them to take informed decisions.
- 1.5 Ensure preparation of all reports about status, progress of schemes, implementation and submit the same to all concerned.
- 1.6 The Committee will be jointly and severally responsible for truthfulness, transparency and prudence in management of all aspects of the Group.
- 1.7 In the event of GP-WSC failing to meet and transact business for three-five months, not undertaking its roles and responsibilities effectively as per the notification and guidelines, misappropriation of funds, embezzlement of funds or office bears acting in a manner benefiting themselves or close relatives, the ZP Sabha can re-constitute the committee.

Planning

- 2.1 The responsibilities of the MVWSC would be to put forth the requirements of the users (group of GPs) in terms of preferences for technology, site selection, infrastructure requirements such as household connections etc. to the department for consideration.
- 2.2 To request ZP to convene Zilla Parishad meeting and disseminate/ discuss/ seek, as and when required, endorsement for the plans.

Implementation/ Construction

- 3.1 To sign off payments made during implementation stage for SLWM.
- 3.2 To co-ordinate with the department during the project implementation period.
- 3.3 To participate in the socio-technical inspection process of the completed scheme.

Operation & Maintenance

- 4.1 Coordinate with the department & GPWSCs to carry out O&M of common facilities of MVS.
- 4.2 Handle complaints of GPWSCs related to bulk water supply & O&M of common facilities.
- 4.3 To collect bulk water charges from the respective GPs as per bulk water tariff policy for MVS towards O&M, if entrusted.
- 4.4 To ensure that each and every household/ section have equitable access to water supply facilities and those resources are put to an efficient usage.
- 4.5 To ensure the quality and sufficient quantity of drinking water.
- 4.6 To prepare and revise, as and when necessary, water distribution management plan.
