2	Manufacturer's Authorization: Please note that in Section-2 BDS (page 29), Manufacturer's Authorization is mentioned "NOT REQUIRED"; which is the key proof or certification stating whether a bidder is authorized to quote on behalf of the manufacturing concern.	IV
3	Tender Specifications(Dimensions): Please be noted that tender specifications floated for items like Hot Plate, Bacteriological Incubator, Hot Air Oven etc have dimensions specified which will restrict the bidder to quote his optimum product in an effort to match the tendered dimensions; instead we request you to provide the capacity for the equipment to be tendered like for Hot Plate, the volume capacity, similarly for Incubators and Hot Air Ovens, the Chamber Capacity should be tendered removing	Capacity will conform to specifications. Dimensions are indicative.

6	Product Certifications: Please be noted that equipments floated in tender have no certification norms; which may result in procurement of products having no user safety norms, environemental factors which will not be the case with manufacturers and products having US-FDA, European CE certifications.
