Government of India has received a credit from the International Development Association equivalent to US\$500 billion towards the cost of the Rural Water Supply and Sanitation Project for Low Income States, now renamed as Neer Nirmal Pariyojana. The State Project Management Unit, Neer Nirmal Pariyona, Assam (SPMU, NNP-Assam), an implementing agency, intends to apply a part of the proceeds of this credit to eligible payments under the contract for Supply, Installation and Testing of Equipment, Chemicals and Glassware for Water Quality Monitoring and Surveillance Laboratory in Project Districts of Assam under Neer Nirmal Pariyojana- Assam.
